Workshops

Perkins 101 (for new Perkins key contacts and for the CTE Director credential (Perkins portion))

- This session provides an overview of the purpose of Perkins, associated grant processes, and general federal grant management requirements. This is a face-to-face session, generally for ½ a day. We will make every effort to offer it in conjunction with one of the other workshops noted below.

Sessions about the new Perkins V Local Application

- With Perkins V, we will have a new grant application for all grant recipients in the formula process. This new application will be used for next fiscal year (starting 7/1/20) and is expected to be completed in the new CTE site online, so scheduling will happen closer to when that site is available. We anticipate face-to-face sessions as well as via WebEx.

Welcome to the new CTE Site! (intro to new CTE site with single sign-in for access to Program Approval, Perkins, Data Reporting, CTA, and Access Management modules)

- These will be face-to-face sessions that will provide an overview and demo of the major functionality of the new CTE site that is currently under development. Additionally, participants will be encouraged to bring information to begin submission of a program approval or other work to practice navigating and using the new system with immediate support available from CCCS staff. These sessions will be advertised once the site is further along and will likely be offered (at least some of them) in conjunction with one of the other workshops noted in this section.

Overview of how to manage access to the new CTE site

- One of the great things about our new CTE system is that it will be a single point of entry for folks to access and submit CTE information (program approval, Perkins, CTA, teacher/student data, etc.). Yay! No more remembering multiple passwords! That said, it is a culture shift since some information housed in that system will be highly confidential (i.e. student data). Additionally, the primary designee for every school district and college will have the ability to designate some permissions and access to other contacts from your institution with their log-ins. These sessions will help CTE Directors understand what options are available and start setting up others from your institutions with access. These sessions will be face-to-face and a WebEx version may also be offered. At face-to-face sessions, CCCS personnel will be available to assist you in navigating and delegating access.
