Course Description	Esthetics I is the foundational course for the Esthetician Program. The first level of the esthetician program presents theory and practical application in the esthetics field. Units of study include: introduction to facial and skin care; facial make-up; introduction to disinfection, sanitation and safety. Students also explore career pathways, post-secondary options and career search techniques such as applications preparation, resume/letter writing and interviewing process. Student that complete all levels of the Esthetician Program will be eligible for the Colorado Board for Barber and Cosmetology State licensure exam for Estheticians.
